On behalf of the Ministry of Health of Ukraine we are pleased to invite you to participate the Third Summit of First Ladies and Gentlemen and the Satellite Ministers of Health Meeting which will take place in Kyiv, Ukraine, on September 6, 2023. This year's summit will focus on the crucial topic of mental health. As part of the initiative under the auspices of the H.E. Mrs. Olena Zelenska, we are honored to introduce an international health partnership initiative. The initiative aims to establish effective cooperation between healthcare facilities in Ukraine and abroad.

This year, as part of the Summit, we propose to hold a Satellite Ministers of Health Meeting. The meeting aims to address the issue of human resources for health and the transformation of medical education in the European region, with a special emphasis on mental health and rehabilitation. During the meeting, we also intend to sign bilateral memoranda between healthcare facilities of Ukraine and partner countries, fostering cooperation and experience exchange.

A tentative agenda of the Summit and of the visit of delegations of countries within the framework of the International medical partnership initiative is enclosed. The event will be held in Ukrainian and English, and simultaneous translation services will be available.
