1. Missing Articles

These sentences are missing definite or indefinite articles, which makes the structure grammatically incorrect or unnatural:

- Error: "I'm sorry but that how it works."
- O Type of Error: Missing definite article
 - Correction: Add "is" and the article "that is the way/how it works."
 - Revised sentence: "I'm sorry, but that is how it works."
- **Error**: "What's the key models in that?"
 - Type of Error: Article mismatch and subject-verb agreement
 - Correction: Use "What are" for plural subject "models" and retain "the."
 - Revised sentence: "What are the key models in that?"

2. Incorrect or Missing Verb Forms

These sentences feature incorrect verb tense or are missing auxiliary verbs:

- Error: "So, let's say he working on a marketing plan."
 - Type of Error: Missing auxiliary verb
 - Correction: Add "is" to form present continuous tense.
 - Revised sentence: "So, let's say he is working on a marketing plan."
- Error: "Now they planning a marketing campaign."
 - Type of Error: Missing auxiliary verb
 - Correction: Add "are" to form the correct tense.
 - Revised sentence: "Now they are planning a marketing campaign."
